## TERMS AND CONDITIONS

**These terms and conditions apply as of October 13, 2021.**

**RESERVATION CONDITIONS:** The reservation becomes effective only after validation. Any stay will be recorded, to the extent of available places. Moreover, Camping Le Réve offers quiet and family oriented stays, in the traditional sense, and the facilities on the campsite are specially designed for this purpose. Le Réve thus reserves the right to refuse any reservation which would be contrary to this principle, or which would seek to divert it. All rentals are nominative and can not, under any circumstances, be assigned or subleased. The person making the reservation must be at least 18 years old, legally able to contract in accordance with these rental conditions and able to guarantee the accuracy of the personal information. Reservation requests including minor children unaccompanied by a responsible adult will be refused.

**DEPOSIT AND BALANCE:** a 30% advanced payment is required to validate the reservation. The balance of the reservation must be paid no later than one month before the arrival date (rental) or on arrival at the campsite (pitches).

**RATES AND TAX:** The prices indicated are valid for the 2022 season and are in Euros, including VAT. The amount of the tourist tax is applicable per day, for each person over 18 years old. The age to be taken into account in the price lists is the 1st day of arrival on the campsite. If the birthday takes place during the stay, we offer to maintain the rate of the previous bracket for the rest of the stay.

**ARRIVAL AND DEPARTURE:** arrivals and departures are daily, except for high season rentals (Saturday to Saturday only).

**Pitches:** the pitches are available from 14:00. They must be released before 12:00.

**Rentals:** rentals are available from 16:00.

Departures must be done before 10:00

Please let us know if your arrival should be delayed. The reserved pitch or rental will be kept for 48 hours from the scheduled date of your arrival. After this time, without notice from you, we shall re-use the place. In case of late arrival or early departure from the dates mentioned on your reservation, no refund will be made.

**INTERNAL RULES:** the reservation of a stay implies the commitment to respect our internal rules (posted at the entrance of the campsite, copy given on request).

**PITCHES & RENTALS:** our pitches and rentals are designed to accommodate a maximum of 6 people (including babies) and one vehicle, exception for Morphée hut for 7 people.

**Pitches:** the booking, for a maximum of 6 people, includes the location for the tent or caravan and a motorized vehicle.

**Rentals:** the rental includes the residence for the

number of persons indicated and a car. Bed sheets are not provided in the base price but available as option, blankets or duvets are available. A deposit of 60€ will be required upon arrival. This deposit will be refunded at the end of your stay, possibly after the cost of missing equipment, repair or damage. Final cleaning is the responsibility of the occupant unless you choose the "end-of-stay cleaning" (option at 60€). Remember to take the necessary to do the dishes. If the rental is not made clean and in perfect condition, the deposit of 60€ will be retained for cleaning fees. All rentals are non-smoking.

The occupant must ensure the peacefulness of the accommodation and use it according to the destination of the place. Animals are allowed, leashed in the campsite, except 1<sup>st</sup> and 2<sup>nd</sup> categories (vaccination book requested on arrival). All the natural needs of your animals must be picked up and thrown in the bins at the entrance of the campsite. Pets are not allowed at the pool.

**WITHDRAWAL PERIOD:** in accordance with article L.12120-4 of the Consumer Code, all services and services offered are not subject to the right of withdrawal fixed in articles L.121-20 and following of the Code of Consumption. As a result, the services of accommodation and leisure services ordered are exclusively subject to the cancellation conditions below.

**CANCELLATION:**

**Due to customer:** any cancellation request must be made in writing. In case of cancellation of your reservation Camping Le Réve applies the following conditions:

- up to 60 days before the arrival date, the customer will obtain a full refund of the amounts paid
- up to 30 days before the arrival date, the client will get a 50% refund of the deposit paid
- less than 30 days before the date of arrival: the customer will benefit from a credit note for the totality of the sums paid, valid for the seasons 2022 and 2023 for a new stay. This credit note is not refundable.

**Due to campsite:** in the event of cancellation of a stay for our reasons, except for cases of force majeure within the meaning of Article 1218 of the Civil Code, the customer will get the refund of all the payments.

**Case of force majeure:** we will examine together the impact of the event and will agree, if necessary, the conditions under which the execution of the reservation contract can be resumed.

**Special case COVID:** In all the following proven cases:

- You or a person accompanying you during your stay is affected by the coronavirus.
- You are limited in your movements by a number of kilometres, preventing you from going to the campsite.
- The campsite is administratively closed

- You are subject to quarantine upon arrival or return from the campsite.

We offer you a voucher for the full amount paid, valid for two years. If you prefer, and at your request, we will refund all the sums paid in full.

**INSURANCE:** during their stay, guests benefit from the operator's third-party liability insurance for any personal injury or property damage for which we would have been held responsible for them. On arrival at the campsite, it is the customer's responsibility to have a valid insurance for their equipment and a third-party liability insurance.

**PERSONAL DATA:** regarding the personal information that you would communicate to us, you have a right of access, modification, rectification and / or deletion in accordance with the law on the protection of individuals with regard to processing of personal data n° 2004-801 of 6 August 2004.
